The most commonly used option for **Japanese Company Incorporation** is establishing any of the following:

- \*\* Kabushiki-Kaisha (KK)/Joint Stock Company: https://sarkaroffice.com/japan-kabushiki kaisha.html
- \*\* Godo-Kaisha (GK)/ Limited Liability Company: https://sarkaroffice.com/godo-kaisha.html

A Japanese address is required for company registration, and a Japanese Telephone is required for post-registration statutory compliance. A Resident in Japan is not mandatory for registering a Japanese Company(KK or GK). Both Promoters/Shareholders and Directors can be Non-Residents.

GK is more flexible for the Paid-up Capital procedure for company registration than KK for Non-Resident Shareholders/Directors.
